**IRS Revenue Resolution 70-604** was passed with a vote of 541 yes, 23 no.

**2023 Annual Budget Overview** – On November 18<sup>th</sup>, your board of directors approved the Annual Budget for 2023. While overall increases vary by neighborhood, the primary drivers for increase include:

- Sports Centers fee increase This is a set increase required annually by the existing contract.
- Reserve increases driven by a new reserve study these funds are required for the planned replacement of our assets. Building up these reserves avoids the need for Special Assessments to replace major assets.
- Landscaping and Maintenance increases As predicted by the Maintenance and Oversight Committee, increases in labor and fuel costs are impacting landscape

maintenance costs in most neighborhoods. We are pleased to announce a new contractor for RECOA landscaping services. Bluestone Gardens and Landscape LLC provided a comparable bid to the incumbent, Land Effects. Bluestone seems eager to work closely with us to meet or exceed our expectations.

More information is on the way! Deborah Bolan has drafted letters which will be sent via snail mail to all homeowners as part of the quarterly Newsletter (to be mailed on or about December 1st). The letters are specific to each neighborhood since each neighborhood has its own 2023 budget. Owners should be looking for that in the first week of December, mailed to their primary address of record with ECM. The letters provide information on the following:

- How the Reserve Studies information feeds future expected costs into the 2023 Budget
- The most significant "drivers" that contribute to dues calculations
- Tables that indicate Master and Neighborhood final dues numbers
- 2022 3rd Quarter Actual and 2022 Year-end Forecasted balances of Operating Funds and Reserve Funds
