Maintenance and Oversight

Projects completed in 2021 included:

- A new walking path along Nutcracker Drive
- West Ridge Overlays in Desert Sky and Highland Meadow Loop
- Over half of the walking/biking trail system was overlayed
- A New Portable Speed sign was purchased. Thank you for your participation in making the roads on the Ridge safer. "Life is Good at 20 MPH"—please keep the roads in our Neighborhoods safe by continuing to drive at 20 mph.
- Forest Green Roof Replacements have been started
- Eagle Creek Deck Replacement
- Managed Neighborhoods had extensive tree removal completed
- Continued roadway shoulder, ditch and culvert improvements to address stormwater runoff

A MESSAGE FROM RUDOLPH: DON'T FEED THE DEER!

Well-intentioned people often feed deer without realizing the myriad problems that human interventions such as feeding can create. Artificial feeding concentrates wildlife, causing the spread of disease and parasites and easier take by predators, like cougars and coyotes. Feeding will invite more deer (and maybe even predators) to your property and encourage them to stay. Concentrating deer in humansettled areas can also lead to an increase in vehicle collisions and conflicts between wildlife and pets. Every year, we see seemingly healthy deer perish because they have been distributed the wrong foods for their diet. Their diet requirements actually change with the seasons and are best met by native forage. Deliberately feeding deer may inhibit digestion and lead to death by starvation or infection. Feeding deer is dangerous and harmful to deer and people alike-don't do it!

The Ridge at Eagle Crest is designated as a High Threat Wildland Urban Interface and is a certified Firewise Community with a definitive program for ongoing grass/brush management, tree thinning and trimming and noxious weed removal and suppression. CWP volunteers tallied approximately 2500 hours during 2021 with the goal of targeted fuel reduction and defensible space maintenance on the 230 acres of Common Area within the RECOA Community.

At this writing, the FEMA Hazard Mitigation Grant Program via Deschutes County is pending RECOA approval. This program allows for fuel mitigation on 77.13 unirrigated acres of the Challenge and Ridge Golf Courses adjacent to residential homes which will give a shaded fuel break for home defensible space. An additional 13.54 aggregate acres on the high terrain upslope from Highland View Loop adds another 75 foot buffer of fuel treatment. Deschutes County would be the contract manager and CWP would provide "boots on the ground" oversight for the contract duration.





2022 FIRE FREE EVENT

The Community FIREFREE Event is scheduled for April 29th - June 9th, 2022. The CWP special focus for 2022 is "The Year of the HIZ" (home ignition zone). During FIREFREE, owners are encouraged to define and accomplish a 30 foot defensible space protective bubble around their homes. Landscape bags of debris and loose larger branches can be placed along the roadside for collection by CWP volunteers and paid contractors. Last year more than 1500 landscape bags and approximately 600 cubic yards (after chipping) were removed from the home ignition zone. A Discretionary Fuel Reduction Grant of \$4400 was received by CWP to expand our FIREFREE program this year to encourage vacant lot owners to participate.

The Greater Redmond Community
Wildfire Protection Plan is scheduled
this year to be updated in coordination
with Deschutes County. This is one of
seven plans that Deschutes County
maintains on a five year update cycle.
This official document is an unequivocal
statement of the wildfire threat to our
community.
