Vendor Activities

For the most part, vendor activities have ceased for the winter season. An exception is Forest Greens roofing which continues on days there is no frost or ice on the roofs. Another exception is culverts and ditches which are being inspected and repaired during the next few weeks.. The first phase of the Vista Rim water feature repair is also in progress.

Maintenance projects that have slid to Spring (or warmer weather) are:

- Road and trail striping
- Village Loop overlay of walkways, driveways, and street
- Roadway and trail crack sealing
- Drainage ditches and culverts maintenance
- Ordering and installation of new parcel boxes at Juniper Glen Circle and Sundance Ridge Loop mail stations
- Speed monitoring with the portable speed radar trailer

The Maintenance and Oversight Committee hopes to take advantage of brief windows of good weather during 1st Quarter of 2022 to begin (or complete) some of these projects. Future eblasts will let you know when these activities will start.

<u>Lastly, I send a reminder regarding a 5% increase in sewer rates, to be implemented in January 2022 by Oregon Water Utilities</u>

If you pay your water bill electronically, you might not "see" the rate increase in January! The 5% increase is applied to the portion of your bill for wastewater (sewer) charges.

If you pay by check, you might actually "see" the increase on your first invoice in 2022.

Per the latest communication from OWU, "the adjustment is a +5% beginning with the January 2022 bills. The increase is a result of the inflation of our operating and materials costs".
