### **Sports Center Vision Ad Hoc Committee Looking for Members**

At the April meeting, the RECOA board voted to create an Ad Hoc Committee to develop a long-term vision for the Ridge and Lakeside Sports Centers. The two Sports Centers are owned and operated by Eagle Crest Acquisition Group. RECOA owners have access to those locations as well as the Resort Sports Center through a Joint Use Easement Agreement (JUEA). We are in the first year of the three-year JUEA agreement and this new ad hoc committee is being organized to identify owner interests and future opportunities well in advance of the next contract cycle.

The committee's deliverables include:

- Gather input from homeowners via homeowner surveys and town hall forum(s)
- Understand our resort land use constraints
- Survey similar resort properties
- Develop a long-term vision proposal for the Board

The committee will include the two members of the Sports Center Advisory Committee (Jim Cox and Sheldon Berman) and three homeowners appointed by the board following a joint recommendation from the Advisory Committee and the two board liaisons serving the committee.
