## **Community Wildfire Protection Committee Notice**

Your **Community Wildfire Protection Committee (CWP)** wants you to know about a near term Ladder Fuel Reduction project effort in work for the Month of March. Note the following:

Collection and disposal of Winter Storm Damage Ladder Fuels. Annually as a part of our Wildfire Protection Program, we survey for damaged trees that can contribute to Ladder Fuel wildfire protection activity. We do this task after 28 February. This Winter season is no exception, and many of you have observed compromised/damaged trees in our Common Areas. On 2-3 March, CWP will be trimming and staging debris from damaged trees in Common Areas on both East and West Ridge. Then , in early--mid March, we will have a Contactor onsite to process the materials. Please, use caution and watch for this task activity when using Eagle Crest Boulevard, William Lyche Drive, and the Community Pathways.

## Temporary Closure of Cycle & Walking Path

Homeowners should be aware that Oregon Water Utility (OWU) will have to temporarily close the cycle and walking path alongside Eagle Crest Boulevard as it runs beside the worksite for their new well supplying Eagle Crest. OWU is adding a new power transformer and running electrical conduit to the well site that requires a trench through the pathway to be cut and then made good. The path will be blocked off and signs posted.

This work is currently planned to begin in the week commencing February 27<sup>th</sup> and is expected to take two weeks.

## Eagle Crest Golf Course

We have been notified that owners have been walking their dogs on the golf course and have been leaving doggie bags full of feces on the golf course instead of discarding them in the proper locations. We have also received notice that owners are walking on the golf course disrupting the flow of normal golf course activities.

Owners are not allowed to walk on the golf course at <u>any time</u>, unless playing golf. This area is not RECOA owned property and is not open to owner access. Please make sure your dog is always on leash and you are walking on the RECOA walking paths not golf course property. We also ask that you please make sure you are picking up and discarding your dog's feces into the doggie stations provided by RECOA.

## New Sports Center Access Cards Update
